



6.1.2: The effective leadership is visible in various institutional practices such as decentralization and participative management:

Visakha Institute of Engineering & Technology promotes and practices decentralization in all academic and administrative activities. It has various academic and administrative committees to monitor, plan and execute the smooth functioning of the college.

Administrative Decentralization:

The Board of Governance comprises the head of the institution i.e, the principal, all HODs, Faculty, Industry Experts, Eminent Educationalists, and Representatives of statutory bodies are responsible for planning and policy development, institutional budget, academic and research growth of the institute and other extension activities. The college Development committee comprising representatives of management, industry experts and alumni is formed to deal with the development plan of the college regarding academic, administrative and infrastructural growth to enable college for addition of curricular, co-curricular and extra-curricular activities.

The principal gives directions to department heads to prepare the annual departmental budget. The HOD conducts a meeting with all the faculty members of the department and asks them to submit requirements along with relevant quotations, depending upon the need of the syllabus and current industry trends. For the acquisition of goods and services, including requisition preparation, funds approval, payments to suppliers and follow-up inquires. College practices decentralization by providing operational autonomy to the departments.

Further, HOD prepare a consolidated report and submits it to the principal for approval. The Principal consolidates the requirements of all the departments and forwards them to the management for approval. The sanctioned budget from the management is received by the institute.

Academic Decentralization:

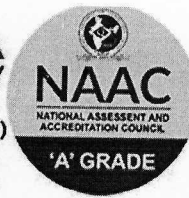
